In consideration of being granted permission to use Silverstone Circuit I **AGREE, DECLARE AND UNDERTAKE**:

- I understand the nature of the activity I wish to undertake and acknowledge the risks involved.
- If driving I confirm I hold a full UK driving licence/MSA/FIA/ACU Competition Race Licence/Kart Licence and/or equivalent from a country outside the UK or I have a T Car, Sax Max, Junior Fiesta or Junior Ginetta licence and will be accompanied by an ARDS licenced Instructor.**
- I am competent to take part in the activity and if using my own vehicle I confirm it is fit for purpose.
- I am not suffering from any physical or mental infirmity nor taking any drugs (whether prescribed or otherwise) that may impair my ability to take part in the activity.
- To withdraw from the activity if for any reason I feel unsafe in continuing and to advise Silverstone Circuits Limited (SCL) and Classic Sports Car Club (CSCC)immediately if any change in my health occurs.
- I shall hold harmless and not make any claim against SCL or CSCC or their employees or contractors, if during the activity my vehicle is damaged, develops a fault or becomes a total loss for any reason or whether as a consequence of being driven by me. I accept that this is reasonable in the context of my decision to use a vehicle owned or under my control for the activity.
- I shall hold harmless and keep indemnified SCL and CSCC and each of their affiliates and each of their (and their affiliates') officials, servants, representatives and agents, and any other person or organisation using the venue in respect of all claims, costs, expenses and demands in respect of death of, or injury to, or loss of or damage to me or my property arising in pursuance of my undertaking the activity (save that nothing in this document shall operate so as to exclude liability for death or injury caused by any negligent act or omission of the aforementioned parties).
- In the event of accident, loss or damage occurring during the activity, I will not pursue any claim for damages against any other participant (save in respect of injury or death).
- I accept I shall be solely responsible for any decision to drive any vehicle or use any equipment at any time whilst it is in my possession or under my control and I acknowledge that if I should be dissatisfied prior to or whilst driving a vehicle or using the equipment as to the satisfactory

condition of the vehicle or the equipment I am required to discontinue driving the vehicle or using the said equipment forthwith.

- I confirm I am solely responsible for my own conduct and my vehicle and that I shall at all times drive in a safe manner to ensure that I do not put myself or other users at risk and in any event in accordance with the instructions provided at the briefing or at any other time during the day.
- I accept that I shall be solely responsible for any decision as to my fitness to participate in the activity. I understand that SCL and/or CSCC reserves the right to remove me from the activity if it considers my actions to be dangerous or detrimental to others.
- I understand that I am obliged to obey any reasonable instructions given to me by any official during the course of my participation in the activity. I understand that I am at no time to venture onto the circuit unless directed by an official.
- If driving my own vehicle I understand I may have a maximum of one passenger who must be over the age of 16 and travel in the front passenger seat only. Passengers who are under the age of 18 must have their indemnity countersigned by their parent or guardian.
- I understand I must wear a helmet for the activity.
- I confirm that any images (moving or still) that I, or any person attending as my guest, take are for our personal use only and may not be used for commercial purposes or broadcasting.
- I shall be fully liable for any damage to property of any individual or organisation caused by me, or any person attending as my guest, arising out of or in connection with our attending the Silverstone Circuit for the purposes of taking part in the activity.
- SCL has in place comprehensive insurance in respect of its obligations in providing the activity and facilities. I understand that such insurance does not apply to my own participation and that I am responsible for providing my own insurance should I require it.
